
"When the Roots are Deep,
There is No Reason to Fear
the Wind"

This ancient proverb still stands true to this day. It

stands firmly in truth and describes and depicts the state of Oklahoma Masonry in the United States. We have all experienced our battles in membership and growth, yet we stand firm and alive.

In its simplest definition, the tree supports all life forms by converting pollutants with its leaves into the oxygen we breathe. With their roots, trees prevent the erosion of our soils. Trees provide two of the most critical aspects of human survival.

Consider how that applies to our lodges, communities, and personal relationships. When practiced in its original and intended manner, Masonry converts our thoughts, actions, and deeds to benefit all of humanity.



When we circumscribe our passions and actions as those of civility and compassion, we are cleaning the prevalent toxic behaviors in society. With our roots, we are preventing the erosion of the very community we live in. With those actions, there is no room for "what's in it for me" and it becomes "What is in it for Us...What is in it for Humanity". That, my brothers, is the core of WHO WE ARE.

We are Masons to make us better men, husbands, fathers, and citizens and to experience the true reason for mankind's existence.

Think it through and ask yourself, what benefit is it to the hive? The bee cannot exist on its own. If it does not benefit the hive (community), the bee and the hive are in peril and will likely perish in time.

NO ONE MAN changes the world all by himself. Remember, Bee + Hive = survival and production.

Differences are what make the world go 'round. It is what creates new ideas and new ways. How differences are handled determines if the change is positive, neutral, or destructive.

Civility and compassion are what determine which actions or words are chosen. That can begin with something as simple as a handshake greeting. Commonly, we shake a stranger's hand when we are first introduced. That handshake doesn't mean, "You are my new best friend". It means I am being polite, following the rules of a polite society, and acknowledging your existence. Now, when we refuse to shake a hand, that makes a loud and clear statement. A thunderous and negative statement. It sets the tone.

At Collinsville Lodge and many others I attend, when a brother walks in, he walks around the room, shaking everyone's hand or saying hello and, yes, shaking hands even with those who did not vote for his idea or even spoke against it.

Your 2025 leadership is and will continue to work to improve the "hive" mentality. It must be done to "have no reason to fear the wind".

Your administration will continue to take steps to stabilize and improve the Grand Lodge's foundation. You elected the Trustees to work for the benefit of Oklahoma Masonry, and we are diligently trying to do just that. This effort will require the support of the Craft to make things happen.

As your Grand Master, I have signed the necessary decisions to waive the waiting period for joining an appendant body. During the 2025 Administration's time frame, I have also made

changes regarding the Perpetual Path Program. In case you are not aware, the Perpetual Path Program combines a constitutionally available perpetual membership and the **program** opportunity "Chance to Advance" or "All in a Day", as they are commonly referred to. This change relates to the **program** portion.

The ability to receive the degrees in one day will still be available but <u>will not</u> include the perpetual membership requirement. The perpetual membership purchase is still available at any time to those who qualify, but the <u>program</u> will be fee-based at a much lower cost, and those fees will be divided between that member's lodge and the Grand Lodge. This change affects the program participant, who must pay his annual lodge dues and per capita to his lodge in place of a lifetime membership.

The reasoning behind this is twofold. One is that a perpetual membership requirement may create a financial burden on the brother when required to pay 15 times the amount of his dues as the fee for the program and a lifetime membership. The other reason is that, as we

all know, most lodges survive on the dues paid by the members, and the perpetual membership annual payout is much less than most lodge's yearly dues. It is a matter of financial survival since when a lodge raises its dues, it only affects a few members and generates minimal benefit to the lodge itself. Brothers, even with a perpetual membership, please consider paying the lodge's annual dues. Let's admit it. We spend more money on coffee, eating out, or other things than on what is the least expensive membership in Oklahoma.

Many appendant body dues are more costly than your Home Lodge dues, and you cannot be in an appendant body without being a mason. You must feed the roots for the tree to bear fruit.

Brothers, I have assembled a very competent team of District Deputies and provided them with Senior DDGMs to help guide and assist the lodges in areas that may require assistance. These men have taken extensive training and have my full support in improving Oklahoma Masonry. They will be working diligently to assist in compliance with the Constitution and Code that the Craft has voted into law, and in doing so, they have tasked the Grand Lodge with seeing it is followed.




Our roots are deep—our commitment is ancient. The results are centuries old.


Board of Trustees, which has three new men who are also a magnificent group of Masons.

4. Collaborating for Cost Efficiency


Encouraging lodges to collaborate on shared expenses—such as joint events or shared facilities—can reduce costs while fostering greater unity among brethren.






